Notable Successes

SOCIAL SECURITY ADMINISTRATION (SSA)

The SSA was facing escalating software costs and capacity constraints. With GreenBookSM and ISAM'S negotiation support, annual software cost growth fell from 20% to 2%, while hardware capacity grew at an 18% yearly rate.
